The Company shall charge the Buyer (unless instructed in writing by a Director of the Company) a carriage charge of £7.00 for gross card orders of under £150 excluding VAT. All copyright, patent, trade secret and other intellectual property rights in the Goods and any all information and advertising material which the Company provide the Buyer or it's agents shall remain at all times vested in the Company and the Buyer shall not acquire any intellectual property rights or license relating to the Goods and may not copy or imitate the Goods, nor shall it license any such rights to a third party. Where the contract is for non-seasonal Goods the Buyer shall (unless instructed in writing by a Director of the Company) pay the Company for the goods no later than 30 days following the date of the invoice. All special offers and free stock deals are conditional upon the buyer making full payment in compliance with the Company's payment terms, where the buyer is in breach of the agreed payment terms the Company reserves the right to invoice the buyer to the full undiscounted value of the Goods. The Company shall have the right to invoice the Buyer for a partial delivery of the Goods. The Company shall have the right to terminate this Contract without notice.
